- (2) I shall be liable to undergo training and attend parades in accordance with the order of my superior officers.
- (3) I shall be required to take the following pledge namely:-

Solemnly and sincerely declare and affirm that I will well and truly serve the Government of Tamil Nadu as a Member of the Home Guardswithout favour or affection, malice or ill-will or communal or political bias; and that I will do the best of my powers, discharge the function and duties assigned to me for the protection of peace, the security of property and the public safety and that I will do the best of my skill and knowledge discharge all the duties as such member faithfully, according to law and will not allow any communal and political bias to interfere with the duties assigned to me by Government or my superior officers."
